Vitreous enamelled stainless steel pot with stainless steel rim and handle made of stainless steel. Glass lid with stainless steel rim and stainless steel handle. Item No. Artikelnr. 4216 8007 18

When used as specified, the transition of substances does not exceed the legal limits and the SRLs (Specific Release Limits) according to Council of Europe Resolution CM/Res (2020)9 on the safety and quality of materials and articles for contact with food (Status: 2020).

The test for enamel was performed according to the standard DIN EN ISO 4531.

all types of food (aqueous, acidic, fatty)

- Intended duration and temperature of treatment and storage while in contact with the food:

repeated contact, short-time also above 100°C

- Ratio of the area of the food contact surface to the volume used to determine the compliance of the food contact material or article made from metal:

5,8 dm<sup>2</sup>/ L
